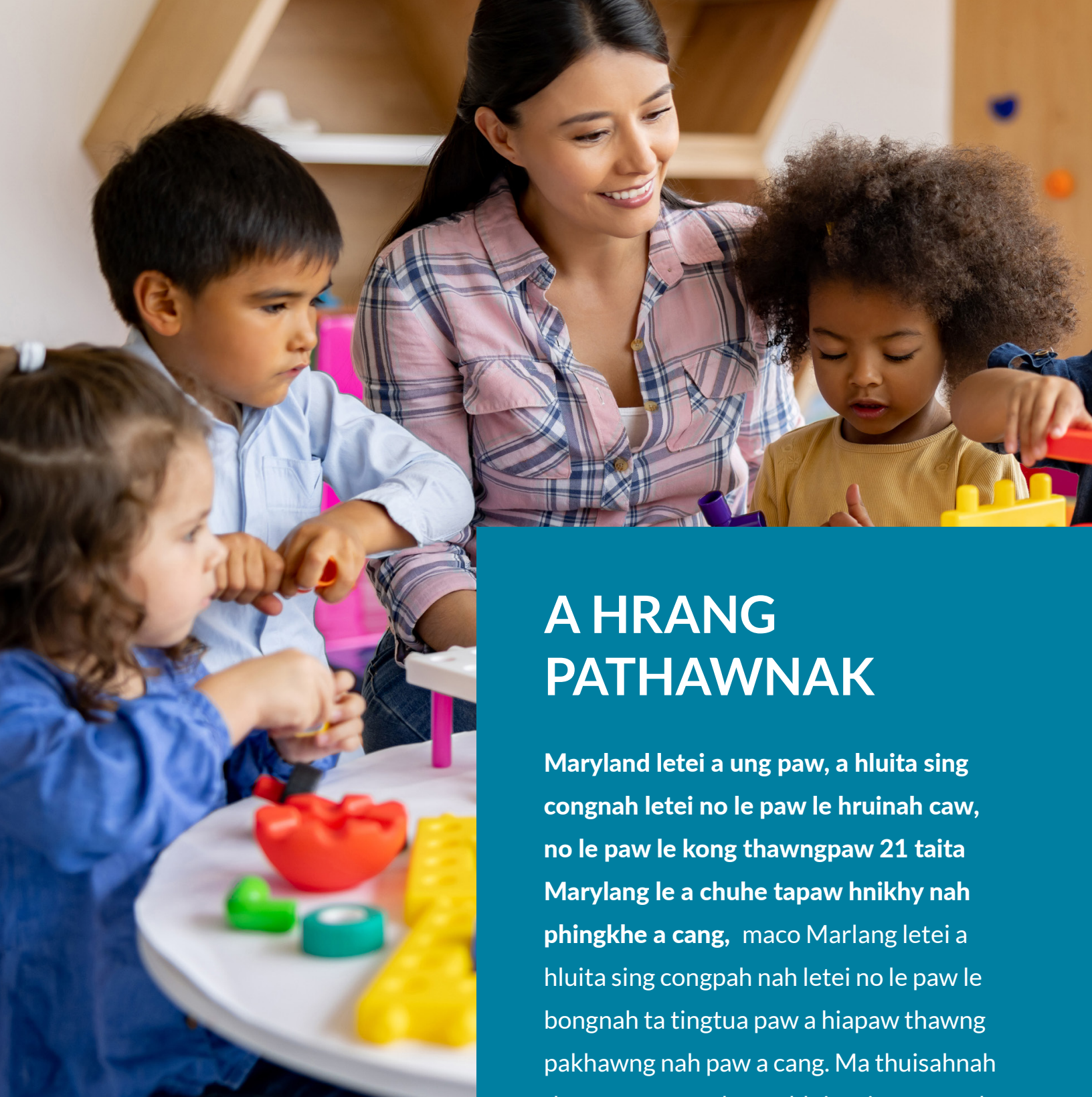

Maryland lai ta a chaw tu paw congpa nah taitah ka cadai he

No le paw ta na sawtei le sianging kenah leta a bapui paw raikha hre ange. Pungtlang tling lypaw a nui paw no le paw caita a chawpaw a cang. Na sawtei tah zetua maw a hong tapaw le zemaw a hia tapaw na hni maw. Na sawtei sianging a pachang taitah, na sawtei ta zemaw a tua tapaw na nuipapaw dukhuinah (vision).

Na sawtei pungtlang tling lyta a cang ning tah, maco pungtlang tling lypaw sianging ke ange ning caita, pungtlang tling lypaw sianging seikhuinah dang hni nah caw a bapui nge paw acang. Nama caw na sawtei caita bongtu chawcai na cang. Pungtlang tling lypaw sianging

seikhuinah dang na fiang co, mataco, na sawtei sianging kenah le ta a ca bong aa. Sianging kening cai cangseh ke khaly taitah cang mata he na sawtei changchy nakha a bong a. Na sawtei sianging a kenah leta nama caw, biachawtu chung leta na teihra. Na sawtei cung leta naw a nuipaw bu tei a hia paw cung leta nama caw a hnipaw le konglang a bipase paw na cang.

Ma cauh chuapaw tahei Maryland letei pungtlang tling lypaw sianging buatla ta binah caw a ung. Mataco sianging kenah tuanah paw letei napaw na tuanga paw rai kha a capa fiang aa, maco meeting na nui paw caita a tingtua paw kha a hni sa.

The Individuals with Disabilities Education Act (IDEA) tapaw rangcung pungpaluh letei pungtlang tling lypaw caitei congna tuapa khynah coza phung sangkheh a cang. Coza sianging le public agencies he tahei pungtlang tlingpaw siangin le hmingkhainah sahlo zekha tapaw a bong he tapaw kha IDEA tahe a hruai he, maco ma congna kha tei a petle paw letei nyheh a chuthapaw, lang aseithaipaw he, nyheh, pungtlng tling lypaw many sahlo vytei caw 7.2 million nahvy tah a thlu aung he. Maryland acoza ta pungtlang tling lypaw a chuanah taitah kung21 a taanah tai kha a chaw teitah a bonghe.



Pungtlang tling lypaw sianging kenah caw zemaw a cang?

Pungtlang tling lypaw sianging caw na sawtei a hiaipaw thainah a hmukhy napaw tei tuapaw a cang. Ma pungtlang tling lypaw sianging tapaw caw, hminghmaw le sianging kenah khang cangbe, mahe caw Pungtlang tling lypaw caitei tuapa paw (service) a cang . Ma service lehei reithlawnah cawngpanah (speech therapy), rawnah penah (conselling) le pungtlang tling lypaw dangsanah (physical therapy) sahlo a tei he. Mahe caw a maily ta pepaw a caw a cang he maco zehming hmaw popo leta chiakhy a cang he. Pungtlang tling lypaw sianging congnahe le tei kenah naw a nga paw sianging nyheh caw amailyta ke awh a tlapaw sing congnahe pe a cang he or FAPE. Ma (service) tapaw congnahe caw, na sawtei kha a maily ta kenah khy a cang tapaw dunah a cang. Ma service caw na sawtei a hiadang paw cung leta angat aa. Sianging leta na sawtei changchy nah kha tingnah caw a cang thlang maco sianging kely ning caita tei ahringnah caita zong acang.



Child Find (Nyheh hmingkhainah)

Maryland sianging system le Local Education Agencies (na ungnah paw kekang taitei sianging langtei bongtu bu) tapaw ta pungtlang tling lypaw sianging ke a dupaw he kha, ma sahlo he a check hringhring a nge, identify, and evaluate children, ages birth through 21. Ma chung lehei na sawtei a teipaw hei:

- Ing leta congnahe;
- Pungpa sianging;
- ingnui ly;
- Avapaipaw le zerai lypaw (hilgily mobile);
- Ungnah paw sang; or
- Catang a aung langmang thlang zongtah pungtlang tling lypaw taatah rawchi paw he.

Coza sianging leta na sawtei na ke saly paw a cang caco, nake sanah paw sianging letei pungtlang tling lypaw a hmingkhaita le nyeh hmingkhainah he kha petlenah na tua khy. Coza sianging leta na sawtei sianging nake sa co, a sayakyi or a saya kha petlenah na tuakhy he.



Maryland's IEP Tua ning cang (process) No le paw ta zepopo lekhe rai a nui

sopannah/mingpasenah (Referral/ Screening)

Na sawtei caw pungtlang tling lypaw ta na rawpaw a cang caco, Individualized Education Program (IEP) tapaw bu meeting leta na na pacang nadang kha reikhy a cang. Sayakhi or saya leta Ca ta nawnah tuakha cawcai paw acang. Rawpanah a ca nui caco, ma saya taco sangsangkeh le sopannah or a chinga.

Sianging taita meeting leta na pacang napaw cehrang pawta a ca sawng aa, maco na pacangnah paw kong hming pahreu na cang aa. Nama taitei na pepaw he, konglang, coza khayana hmu na dang, State coza a hmuna dang, le a khangchung letei a cawcangnah paw konglang sahlo vytei kha IEP bu ta ming paching nah a tua aa.

A cangkhy paw meeting taitei a chuapaw: (1) Cacawng nale tlangtling lynah a ung lyna paw; pacangpah a nge lynah (2) a to cenge leta cacawng nale tlangtling lynah a ung lyna paw, phungning ta a cang zong phungning lyta a cangzong tingtua panah, maco caithlia paw caichung leta konglang (data) kha ming paching paw; (3) Cacawng nale tlangtling lynah a ung lyna paw le a hiachipaw konglang; (4) cacawng nale tlangtling lynah a ung tapaw biachaw napaw caita tlangtling teitah konglang a ung.

Zehapaw hmingmai a ca tuapa hlai leta, Prior Written Notice (PWN) tapaw meeting taitei a chupaw a phi popo kha meeting leta a pe na cang hmasaw aa. Procedural Safeguards tapaw na naw nuinah kong sahlo ca kha pe na cang a.

IEP seinah dang



No le paw le rai:

IEP meeting na kekhy ly cang caco, apating khy nachung na thuisahnah na tua ange, meeting cai kha tuahreu khaw ange na cawta. Sawngnah ca leta petlenah thawng sahlo a teithlu aa. Ma meeting le co, na pacangnah paw le siibo taitei a caching paw le a hringpaw taitei a cape paw thawngpang sahlo vytei kha na thuisah khy he.



Meeting sawngnah

IEP meeting caitei sawngnah ca caw, meeting tuanah ning 10 hlai le ta pe na cang aa. Meeting letat a ho sahlo maw sawng a cang he, maco meeting tei a tingpaw sahlo kha a ca hni sa, maco a ning sahlo a rai le aa hre paw sahlo kha na hni khy aa. Ma chung le co, meeting tuana paw a cai le ning le a hmingshaw sahlo a tei aa. Meeting tuanah paw caw tingtua hrui a cang aa.

IEP bu

IEP bu letei a bapui sahlo a teipaw he:

- No le paw le;
- Zawpui cawngnah le tei sianging nyheh a saya;
- Pungtlang tling lypaw sianging letei sianging nyheh a saya;
- Hruitu or tingtuatu;
- Camipui a phi a fiangkhy paw mingpaching tu;
- A raicang caco, sianging nyheh; maco
- Local Education Agency (LEA) or Public Agency (PA) or no le paw nithuihnah a nui paw he a sawng paw sahlo.

Ma sianging nyheh tei sangsang khe thainah a nui ly caco, aa pungtlang tling nyheh a kenah paw a cang zongta, a cangkhy paw popo taitei a catang kha a khehpaw saya ta a ke khy.

Mingchingnah le ming pachingnah

Sianging kenah leta tlangtling lynah a ung tapaw biachaw nah paw caita a nge maw a hiachi paw konglang a ung caco, IEP bu ta a hia tatah a rawhpaw vytei kha rawnah a ca chy tei aa. Na sawtei tei a hia paw le thawzang sahlo hnikhly napaw caita thawngpang lanah le hmingpachingnah sahlo kha, Sianging letei raihre tuta a macang paw kha hmang khy he.

Ma bu taco ma sahlo he a check khy:

- konglang a ungpaw le mingpachingnah a phi;
- nama no le paw taitei thawngpang;
- cacawngnah khang le rangchung pungpaluh le rangchy vytei taitei mingpachingnah;
- cacawngnah khang leh la nah; maco
- Saya le taitei thawngpang.

Pacangpaw paw vytei kha mingchingnah aa nui thlu aa. Machung letei a tei khy paw he caw, hoikongnah le tei thinglungpuh, ziaza le cacawngnah le thuihnah le hmunah nah test sanah le pungsaw cawcang nah vytei kha tei he. Ma cawngnah (service) leta a teikhly ah co, a ningkkeh nah leta na sawtei ta zemaw a tuakhy tapaw hnikhly napaw kha, konglang pakhong paw thawngpang tahei a bong khy aa.

Macawngnah (service) leta na sawtei ateikhly nah a hmunah paw letei biachawnah le a phichua vytei kha minghreu ruapaw caita, mingpachingnah caitei hnawtlakhuinah ca na hmukhy ning 60 chung leta a hringpaw meeting tuanah a ung aa. Meeting hlai a tlecai ning 5 leta, mingpachingnah aphichuh le a hringpaw ca vytei kha copy pe na cang aa.

Ca tuahrang paw le mingzacin le konglang lanah (survey) sahlo na pachang le chang ly a ca hei mai aa. Fom na phi thlu cangkaw ta nakua kaw he.

Na hni lypaw a ung cacom hei maco a railang teipaw ningta na zui a.

Mingpachingnah (evaluation) leta lungtling lynah a ung ahco, zemaw a cang a?

Mingpachingnah (evaluation) a phi na lung tling ly cang co, azalong paw pungpa evaluator ekha na sia khyma Mingpachingnah (evaluation) caw coza tangka hmangkhy a cang or paraitu (mediation) kha hlang khy a cang or lungtling lynah phisin nah kha ngekhy a cang.

IEE caw, Sianging phung ning teita alailang menungte tuapaw mingpachingnah(evaluation) sangkkeh a cang. Sianging leta tangka bongnah heinah na tuapaw kha pe penah le pely nakong kha, nawnah ca a hmu taita ning 30 chung leta thuisanah kha tua a cang a. IEE tapaw evaluation caw nama na tangka teita zong tua khy a cang. Na sawtei a cacawngnah paw letei biachawnah a tua tihtah IEP bu ta a lailang evaluator kha pacang pai hringhring e ange. IEP tlang pa tlingnah

IEP caw sachoh sangkheh phing a cang. Zuihrang paw kha upa paw; fiang teitah hnikh y hringhring kha nge. IEP letei aung paw popo kha Bu ta fiang teitah riithlia nah tuapaw kha bapui nge tei, maco Bu chung letei a teipaw pungpa vytei tah a lopaw teitah a lung a fiang. Bu chung letei a teipaw pungpa vytei tah a lopaw teitah a lung a fiang napaw cawtah IEP ca vytei kha faingteitah na tua a nge, na hni ly paw a cung caco hei khy a cang he.

Ma IEP letei na ca vytei hmingthlu a cang cangkaw le cong nah le bongnah caw patho a cang a.

Saya le na sawtei le caw na sawtei tingpah pa le pacang papaw caita rai a hrehui aa. Cacawngnah khang chung le hmang a nge hringhring paw hming sahlo a teichi ta, IEP chung letei a ung paw na sawtei konglang vytei kha na sawtei a saya le vytei kha pe thlu a cang he. Tingpah le pacangpahpaw caite changchy napaw thawngpang kha saya le ta a pakhong pa he.

IEP le palang cia paw hrata, or cawngnah chyching(quarter) popo le ta changchy nah report caw pe na cang a. Na sawtei a changchy lypaw a cang caco, IEP letei zemo a thlai a nge tapaw reihrang pawta IEP meeting caw tuahring hring a nge. Ma caco, na sawtei ta cawngpah nadang a macang le cai a hlu vy a hia khy na caw a cang khy mai, acang lyle, tingpa paw kha parai pahreu a nge mai a.



No le paw le rai:

Ing leta na sawtei zemo ka bong khy ah tapaw kha saya le kha hei. Napacangnah le acingkaitlapaw kha saya lekha thuihsa. Na pacangpahnah le thawngpang thapaw na nui caco, meeting tuapaw ta na nawkhy he, acangly le, na sawtei a changchy vy ly ah co.

Kung tingta IEP minghreunah

IEP tuahreun paw tale, na sawtei a changchynah minghreun (review) tua ruapaw ta a congcai kungkhe leta voikkeh caw IPE bu taita meeting aa tua hringhring ange. Na sawtei ta a hia paw hmu khy napaw caita, Changchy ning teita a changchy thlang cang co, IEP ta chawtei ta pezui kha a hia nge paw a cang. No le paw or saya le ta meeting tua ange a ta cang caco, IEP meeting caw a to le to ta tuakhy a cang.

IEP meeting hlai ning 5 leta, meeting letei aruahrang paw ca vytei kha na ing le a va cakua. Meeting hlai ning 5 leta ma ca sahlo caw a cakua ly caco, meeting kha pathawn paw ta na naw(request) khy he ma ca sohlo mingpachingnah (review) tua na paw caita. IEP a ciangta (draft) a tua paw caw na ing le a cakua mai aa. IEP draft caw biaruah paw patho nah a cang taatah na thinglung le na chia. Meeting chung leta, ma na ing lang ka va cakua paw draft kha a thlai khy leimei.

Ma na ing lang a va cakua paw caco hmingpachingnah (review) tua kha a bapui nge tei, biahei hrang na nui paw kha na cing kai ah (note) Ing leta acanglyle ahringpaw cawcangnah letei na sawtei caita rai na nuipaw kha reihrang pawta tiangtua nah na nui ah, mataco sianging le na sawtei changchy napaw kha a bong khy mai a. Meeting hlai leta biahei hrang na nui paw le rawnah chua nadu paw kha na sawtei a mingkhaitu (manager) leta na kua a, IEP bu ta pale hrangpaw caita tingtuana cai aa nui napaw ta.

Sangsang kheh na lungtling ly napaw, pafiangnah, le paraihrang paw sahlo caita le IEP bu taitei adongnah rawnahpeh paw aa tuapaw sahlo cung letei rawnah chy na du paw he caw chaw teita tingtua nah na nui aa. IEP buchong leta mai a nuipaw le a khyng pawta naw a nui paw na cang. IEP bu leta le seikhuinah leta nama na o ang le biahei nah caw a bapui nge paw a cang.



No le paw le rai:

Meeting leta na teikhy lo cang co, meeting caikha na tuahreun khy kaw. Na pacangnah le teinah hmunah caw IEP bu le thuisanah na tua. Sianging le ingle tuahrang paw ca khata apette ta, ingle ta na rawpaw kong kha na rei aa. Thlaina dangkha sohlo kha rawpai ta rawnah na chuah khy. Meeting hlai cangseh meeting khy cangseh, ingle ca a cakua paw vytei kha mingpachingnah (review) na tua.

Na rawnah le na pacangnah sahlo pekhy a zong.

Mingpachingreun kawnah (re-evaluation)

Acongcaitah kung³ le voikkeh caw, na sawtei caw pungtlang tlingpaw sianging leta kecong nah naw a nui le nui ly kha biachawnah a tua hring hring a. Na sawtei te a hiapaw le thawzang sahlo kha petle ta a tocai letei thawngpang a nuipaw kha chawtei ta a fiang a du. Thawngpang thapaw a nge le, a canglyle a pacangpaw sangsang kheh aung sua ah co, no le paw leh le saya leta camipuai tua pating vypaw caita naw nah aa tua khy.

Atoningcai letei na sawtei a cacawngnah letei biachaw nah le, a canglyle, ma sianging leta kecong nah naw a nui napaw ta a hluita thawngpa or konglang a hia ly napaw kha IEP bu ta biachawnah a tua mai aa. IEP buta a hluita mingchingnah a hia tapaw zong a biachawnah a tua mai a. IEP minghreunah le mingpachingnah le tei a phi achupaw kong biaruahrang paw ta naw na pekhy tai heta, ning 90 chung leta a tongkaw nah a ung aa, a nga caco.

Nyeh mingkhainah (Child Find)

Coza phung tei tuaheseh tapaw a dupaw cawcangnah sahlo, maco pungtlang tling lypaw sianging a nge paw sianging nyeh sahlo kha, aning kha petle paw biacetu tu fiangsanah le chianah le mingpachingnah kha a tua he.

Hnawthlanah

Tuapa nga maw tei songnah caw cacia nah ta hnawthlanah tuapaw.

Mingpachingnah (Evaluation)

Nyeh pakkeh pungtlang tling lynah le pungtlang tling lypaw sianging tale makha tei a petle paw ahiapaw a hmukhy napaw caite cawngnah (service) vytei, a hiapaw a cang maw cang ly tapaw biachaw naa paw ta, akhanchung le acawcangnah paw kong le mingpachingnah a phi vytei no le paw le taitei thawngpang acangpaw kha mingpachingnah (review) tuanah dang a cang.

FAPE

Pungtlang tling lypaw sianging letei a kepo hmaicaw, Free Appropriate Public Education a mailly ta kekhy nah kha a hmu.

IDEA

Pungtlang tling lypaw sing congngah phung. Mahe caw pungtlang tling lypaw sing congngah phung sangkkeh acang.

IEP

Pungtlang tling lypaw sing congngah. IEP bu tei tuapaw cacianah a cang. Ma taco na sawtei bongnah paw caita tuapaw chaw teita cawngnah le bongnah le tuapahnah sahlo vytei kha a palang sa he. Nyeh pakkeh cytei a hia paw cungle a ngat ta IEP caw tua a cang.

IEP BU (IEP team)

Pungtlang tling lypaw congngah a hiapaw sianging nyeh kong biachawta bu a cang e. No le paw le caw, IEP buchung letei a bapui paw chungtei acang e.

LRE

Pungtlangtling lypaw tei punghman ta cacawng nah taitah thairang paw kha a thai ange tapaw program (LRE). Na sawtei IEP caw zele tamo na tongkhy aa. Pungtlang tling lypaw sianging nyeh ta pungtlang tlingpaw sianging nyeh pakkeh khang a cangkhy nachung ta thaisanah kha sianging a rai a cang.
